

Whereas on the application of Wm. Burt and the heirs of John Burt dec'd to bring said Estate into Hotch Potch [legal term: refers to the blending or combining of property in order to ensure equality of division ] a Jury was summoned being Henly Brown, Matthew B. Rice, Eli Abbott, Patrck Cavanaugh, Sam'l Carruthers, Wm. R. White, Abraham Doster, Organ Tatum, Charles Mims, Thornton Rice, Henry DeBardleben, & Wm. S. Hadnot, who found that John Avent had received five hundred & Sixty two dollars, William Burt Twenty five dollars and Zacheus Burt Three Dollars out of said Estate and that the other heirs of said Estate had received nothing.

This day came Stephen M. Burt Adm. of John Burt dec'd & made a report & final settlement of said Estate

Ordered that said Adm, pay to Hannah Burt widow of said John Burt Nine Hundred Dollars & 82/100.

Ordered that said Adm. pay to William Burt Three Hundred & thirty six 19/100 dollars.

Ordered that said Adm. pay to Zacheus Burt Three Hundred & fifty eight 18/100 dollars.

Ordered that said Adm. pay to Wm. Burt Adm. of Joseph J. Burt Three Hundred & sixty one 51/100 dollars.

Ordered that said Adm. pay to Wm. Burt Guardian of Jno. Burt Three Hundred & Sixty One 51/100 dollars.

Ordered that said Adm. pay to John Marshall Guardian of Pendleton J. Marshall Three Hundred Sixty One 51/100.

Ordered that said Adm. pay to Jno. Huddleston Guardian of B. H. Burt Three Hundred & Sixty One 51/100.

Ordered that said Adm. pay to Jno. Huddleston Guardian of Alex. H. Burt Three Hundred & Sixty One 51/100.

Ordered that said Adm. pay to Jno. Huddleston Guardian of Eliza Burt Three Hundred & Sixty One 51/100.

Ordered that said Adm. pay to Jno. Huddleston Guardian of Margaret Burt Three Hundred & Sixty One 51/100.

Ordered that said Adm. pay to Jno. Huddleston Guardian of Francina Burt Three Hundred & Sixty One 51/100.

Ordered that Stephen M. Burt be discharged from the further administration of the Estate of John Burt dec'd upon payment of the above sums of money.

Note: John Burt was a son of Joseph & Elizabeth Burt of Halifax Co., NC and died in Autauga county about September 1827. Married 1<sup>st</sup> Elizabeth Marshall & had Rebecca Burt m. John Marshall, and Mary Burt m. John Avent. Married 2<sup>nd</sup> Hannah and had Stephen M. Burt, Dr. William J. Burt, Zacheus Burt, Joseph J. Burt (died 1829), John Burt, Burrows H. Burt, Alexander H. Burt, Eliza Burt, Margaret Burt, and Francina Burt.
